#### **LOCUM REIMBURSEMENT**

The LMC is aware in neighbouring areas that a number of practices have been inappropriately denied locum reimbursement by the local NHS England team when GPs have come back from sick leave on phased return for a limited number of weekly sessions.

Their LMC has challenged this with NHS England's national leadership through the GPC. NHS England has now fully conceded the LMC's position that practices must be reimbursed, in line with the stipulations of the Statement of Financial Entitlements (SFE) for all sessions where cover is required when a GP returns from sickness absence on reduced sessions.

Please advise the LMC if your practice has any issues with receiving the locum reimbursement it believes it is legally entitled to.

#### **Important Note about GDPR**

The upcoming changes to data protection regulations (GDPR) will affect any organisation that holds 'personal data'.

The only personal data that the LMC Buying Group holds about its members is a name and email address of a main practice contact for a member practice. This information provides the Buying Group with an easy way to contact a member if there is an issue with your practice's membership or if the Buying Group needs to communicate important information such as the recent changes to flu vaccine policy.

However, due to the GDPR regulations on personal data being more prescriptive than the current DPA rules, we need **ALL** members to re-register with us (if you haven't done so already). #### **WORCESTERSHIRE ISSUES**

#### **REFERRALS TO THE UMBRELLA PATHWAY**

The LMC has had discussion with Worcestershire County Council regarding recent changes to the Umbrella Pathway which has been directly communicated to practices. It has become clear in discussions that in some cases schools are inappropriately directing parents to their GPs when these are matters that the school should deal with. Clearly, GPs, in most cases, are not in a position to fully complete the Umbrella Pathway Referral Form. Schools have been made aware of the new referral guidance and in many such cases it is appropriate if the parents are referred back to the schools. If practices are having schools repeatedly not taking on this responsibility please inform the LMC and we can pass this information onto the County Council.

Clearly, referrals to a specific service appropriate to the child's presenting need such as speech, language or feeding problems are something that GPs can deal with and can make appropriate referrals.

#### **SHARED CARE AGREEMENTS**

For a considerable period of time Worcestershire LMC has been unhappy with the so called Shared Care Policy that exists in Worcestershire. Interestingly, the matter has now come to the fore with our neighbours and there are serious concerns in Warwickshire and the matter was also discussed at Herefordshire LMC's last meeting. NHS England has published a very detailed and explicit policy document entitled "Responsibility for Prescribing between Primary and Secondary/Tertiary Care" (please see link below.)

This details quite specifically how these issues need to be addressed. It is very apparent that this is a matter that CQC are taking very seriously and is coming up at inspections locally. The LMC has requested a meeting of the appropriate representatives from the Acute Trust, Health and Care Trust and the CCG to formalise and bring the system up-to-date. If any GPs are interested in this area and wish to make any comments or input into the discussions please contact the office.

#### **DOCMAN10**

Many practices have had some technical issues with Docman10 the new paperless system implemented and this is having a negative impact on the productivity of some practices. This is because of log in problems and slow functionality.

If practices are having issues these should be reported to Allyn Thompson on <u>allyn.thompson1@nhs.net</u> at the CSU as he is the person managing the Docman 10 migration project.
